In-Text Citation An in-text citation can appear in parentheses after a paraphrase or a direct quote. It includes the author's last name followed by the year of publication and page number, if applicable. For a chapter in a book, only the chapter's author is included; there is not need to mention the editor or book title.

To create a reference for a chapter in an edited book, follow the example for a chapter in an edited book without a DOI. At the end of the reference, after the publisher, add the DOI using the current DOI URL format. The current standard for the DOI begins with "https://doi.org/". Do not add a period after the DOI.

To cite a chapter in a book in a reference entry in Harvard style include the following elements:. Author(s) of the chapter: Give the last name and initials (e. g. Watson, J.) of up to three authors with the last name preceded by 'and'. For four authors or more include the first name followed by et al., unless your institution requires referencing of all named authors.

APA Format Broken Down: Use this format if you are using 1 chapter out of a book that has many chapters, and each chapter is written by a different author. If each chapter is written by the same author, just cite the entire book. Parts of the APA Citation Explanation Author's Last name, First initial.

How to Cite an E-Book Chapter in APA Format This follows the same structure as an edited book chapter reference except the publisher is exchanged for a URL. The structure is as follows: Last name of the chapter author, initial(s).

The APA in-text citation for a book includes the author's last name, the year, and (if relevant) a page number. In the reference list, start with the author's last name and initials, followed by the year. The book title is written in sentence case (only capitalize the first word and any proper nouns).

To cite the entire anthology or collection, list by editor (s) followed by a comma and "editor" or, for multiple editors, "editors." This sort of entry is somewhat rare. If you are citing a particular piece within an anthology or collection (more common), see A Work in an Anthology, Reference, or Collection below.

### MLA Works Cited Page: Books // Purdue Writing Lab

When referring to a chapter in an authored book, usually you would not cite that chapter in the reference list. Instead, you would cite the whole book and, if necessary, cite the chapter in text. This rule applies whether the chapter is written by one of the book's primary authors or by a separate contributor.

### APA Style 6th Edition Blog: How to Cite a Chapter Written ...

To cite a book chapter that your professor uploaded to a Web site, begin with the MLA format template. List the author of the chapter and the chapter title. List the title of the Web site as the title of the container, not the title of the book, since you found the chapter on the Web site rather than in the book.
