Contracts usually provide three different methods for pricing change orders. These methods may be described and detailed within the changes clause, or may be included in a different section of the general conditions. The three methods are the following: A unit price contained in the contract. A lump sum negotiated price.

**Fundamentals of Construction Contracts: Pricing of Change Orders**

Any changes requested by the owner or contractor which affect MBTA property or operations must be submitted to the MBTA for review and approval at least 30 days prior to the planned commencement of the work. Approvals or rejections shall be submitted by the MBTA within thirty (30) days following submission to the MBTA for review.
